Open to all breeds and mixed breeds, ages 6 months or older. Dogs must be registered with Barn Hunt Association, LLC to participate. Entries open on February 12<sup>th</sup>, 2016. Pre-entries will be accepted in the order received until the limits are reached or until May 13<sup>th</sup>, 2016 at 9:00 pm CST.

These trials are PRE-ENTRY ONLY, No Day of Show Entries, Maximum of 10 dog entries per envelope

Classes Offered: RATI, RATN, RATO Entry Limit per Day: 120 Runs

Trials held Indoors (heated/c/air).

There will be **limited** indoor crating for entered dogs.

#### **Class Descriptions:**

RATI (Rat Instinct Class): Three PVC tubes placed in plain sight on the course. Tubes will be: one dry, one with litter only (no rat), and one with both litter and a rat. Time Limit: 1 minute.

RATN (Novice Barn Hunt): Three PVC tubes hidden on the course. Tubes will be: one dry, one with litter only, and one with both litter and a rat. Time Limit: 2 minutes.

RATO (Open Barn Hunt): Five PVC tubes hidden on the course. Tubes will be: one dry, two with litter only, and two with both litter and a rat. Time Limit: 2 minutes 30 second

#### **Running Order:**

Dogs will be run in height order with dogs being handled by the same person separated into different staged groups. Friday will run small to large; Saturday will run large to small.

Classes offered each day as listed above: trial 2 will follow trial 1. Move ups will be allowed between trials if competitor contacts the trial secretary to fill out the move up form within 30 minutes of receiving qualifying score confirmation. Facility will open at 12:00 pm Friday & 7:00 am Saturday.

Entries will be accepted as received. Your entry must be complete with BHA number and signed liability waiver. We reserve the right to limit entries to fall within the time constraints of a judging day and a maximum of 120 runs per judge per day.

Entry fees are Instinct - \$15; Novice - \$20; Open - \$20; **No Day of Entries will be taken**; All entries must be accompanied by entry fees to be valid. A returned check does not constitute a valid entry, there will be a **\$35 NSF fee** for any returned check. **SORRY – NO CREDIT CARD PAYMENTS!** Be sure your email address is legible, if you do not receive an email confirmation please contact the Trial Secretary.

Qualifying ribbons will be awarded for all qualifiers in all classes, including Instinct. Placement ribbons will be awarded for 1st through 4th in each height division for all classes except Instinct. New Title ribbons and High in Class ribbons will also be awarded. Additional awards may be given at the discretion of the Club.

#### **Exhibitor Information**

It is expressly understood that participants alone are responsible for the behavior of their dogs. Any participant whose dogs create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the event committee, be asked to leave the event site. In such case, no refund of any fees paid will be made.

The REGINA KENNEL and OBEDIENCE CLUB ("RKOC") and all persons associated with running this event will assume no responsibilities for any loss damage or injury sustained by participants or spectators, or to any of their dogs or property.


- Barn Hunt Registration Number and Barn Hunt Rules and Regulations may be obtained on the website, www.barnhunt.com.
- Entries made without fees or signature and a completed Waiver and Indemnity Form will not be accepted.
- If you provide your email address, we will acknowledge receipt of your entry via email within a few days. If you do not receive an initial confirmation within one week of submitting your entry, contact the Trial Secretary. Any errors must be reported prior to the commencement of the trial. If you do not have email but want us to confirm receipt of your entry, please include a mailing address with your entry. A \$35.00 service charge will be added for any returned cheques.
- Entry fee(s) will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee. Entry fee(s) will not be refunded if the Trial cannot open or be completed by reason of riots, civil disturbances, fire, act of God, public emergency, act of a public enemy, or any other causes beyond the control of the organizing committee. Abuse of any kind towards volunteers or trial committee will not be tolerated and will result in immediate dismissal from the event.
- Withdrawals after the closing date due to injury of the dog will be eligible for a 75% refund of
  entry fees paid upon receipt of a note from your veterinarian. The note must be dated and
  emailed or mailed to the Trial Secretary prior to the close of the trial on Sunday afternoon.

- All dogs must be on a short leash (6') and under control at all times, while on trial grounds, except when in the ring for judging. Approved collars include flat snap or buckle collars of solid construction and leather or nylon leads. Limited slip martingale collars are allowed. Single piece slip collars/leads are allowed. Harnesses, with the exception of head-halter types, are allowed. Dog must run "naked," without a collar/harness. The actual course area will be securely enclosed. No flexi-leads or head halters allowed within the show building. Per BHA rules, electronic collars/devices are not allowed anywhere on the site this includes electronic bark collars. Prong collars may be used on the site while walking dogs, but are not allowed while the dog is competing.

- Bitches in season are eligible to compete. They will run at the end of each class. Bitches in season must compete in panties specifically designed for the purpose of preventing/containing seasonal discharges; Owners of bitches in season will confine their dog(s) away from the trial area and other dogs, post "dog in season" signs in their area, and potty area. Owners must make their condition known to the Trial Secretary prior to the start of the trials and inform all exhibitors at the Judge's briefing.
- It is the exhibitor's responsibility to be ready for their runs. The club has no obligation or responsibility for calling or locating dogs that are not brought to the ring when required.
- There will be a short dinner break at the judge's discretion. A dinner/desert & beverages will be available for purchase.
- BHA rules and Common Courtesy: Exhibitors are responsible to clean up after their dogs. Dispose of waste in appropriate containers provided around the building.
- Possessing or training with personal, live quarry is not permitted on show grounds at any time. Food and toys are not permitted in the ring. Squeaky toys are not permitted in the building.
- Show courtesy to all competitors. Manage loud or disruptive dogs. Treat every dog as if they
  were reactive or spatially challenged and remain aware of what your dog is doing at all times.
   Every dog and exhibitor deserves to have a pleasant experience.
- These trials are held indoors in a Heated/C/Air facility. There will be limited crating space for entered dogs only. No ex-pens allowed in the building. Please observe marked crating location.
- There is NO SMOKING in this facility. If you must smoke, please do so inside your vehicle and dispose of the butts in the vehicle.

All dogs must be under control and on a short leash while on trial grounds except while showing.

Pet Policy

Property is Pet Friendly. Guest must contact the property when they wish to book a pet room. **Pets allowed based on the availability of pet friendly rooms.** Up to 2 dogs with an 80 lb. weight limit. Additional pet types (cats, birds etc.) may be accepted at the Hotels discretion. Pet rate is \$20 per day with a \$100 per week maximum. A refundable cleaning; damage deposit of \$50 is required upon check-in. If damage occurs or excessive cleaning is needed, the deposit can become non-refundable and the Hotel may charge additionally to cover the costs of cleaning.
